

The Process Industry Competence Network






### Mission

#### **Organization and Communication**

- The SIG is lead by the chairman Eelco Linnert who coordinates the program for the SIG. Vice-chair: Mariska van Dalen. Support functions (e.g. facilitator, graduate student) will be established on an as-needed basis.
